## CONTRIBUTION GUIDELINES

- 1. *Migration and Development* is a biannual journal of scientific research edited and published by the International Network on Migration and Development.
- 2. Contributions must not have been previously published and cannot be submitted to other journals for simultaneous consideration. They must provide results or advances in high-profile original research within the field of social sciences and focus on specific issues involving international migration and development. Contributions can be in Spanish or English and will be published in those languages. Authors must agree to have their work disseminated across print and electronic media by the International Network on Migration and Development.
- 3. Authors must submit originals in Windows and Word compatible format, on 8.5" by 11" single-sided pages, Times New Roman 12- point type, and double-spaced throughout.
- 4. Considering that a page has 27 lines and between 60 and 64 characters with double line spacing, submissions will have a total of 20 to 25 pages. Texts for the Voice of the Actors section shall be between 12 and 15 pages, and those for Juncture and Debate between 15 and 20.
- 5. The article must include the following information, which should not take more than ten lines: full name of the author or authors, nationality, academic title, institution, affiliation and research topics, position, telephone, mailing address, electronic address, bibliographic references to two or three recent publications, and any other information deemed relevant.
- 6. A 150-word (or ten-line) abstract in the article's original language and five keywords to facilitate inclusion in indexes and bibliographic databases must be included with the manuscript. *Migration and Development* will translate, when necessary, into English and will use said abstract to disseminate the research using the Network's website.
- 7. Tables, maps and graphs must be in Excel format and contain clear and precise data; they must always include the original data source

and the main article text should indicate their exact desired location.

- 8. Notes shall be included at the foot of the page and must be singlespaced, numbered consecutively, and appear at the bottom of the corresponding page. Footnote call-outs must be indicated in numerals.
- 9. Citations must be built into the text using parenthesis and author surname, year of publication and page number. Example:
- Complete bibliographic references will be included at the end of the text, in alphabetical order and as follows:

BOOKS.

Author's surname, name [followed by name and surname in the case of additional authors], (year), book *title*, place of publication, publishing house.

Example:

Petras, James and Henry Veltmeyer (2003), *La globalización desenmascarada. El imperialismo en el siglo XXI*, Mexico, Miguel Ángel Porrúa. CHAPTER IN A BOOK.

Author's surname, name [followed by name and surname in the case of additional authors], (year), "chapter title," author(s) of the book, *book title*, place of publication, publishing house.

Example:

Orozco, Manuel and Steven Wilson (2005), "Para que las remesas produzcan resultados," in Donald Terry and Steven Wilson, *Remesas de inmigrantes. Moneda de cambio económico y social*, Washington, BID.

MAGAZINE ARTICLE.

Author's surname, name [followed by name and surname in the case of additional authors], (year), "article title," *journal title*, place of publication, year, volume, number.

Example:

Kandel, William and Douglas Massey (2002), "The culture of Mexican migration: A theoretical and empirical analysis," Social Forces, vol. 80, no. 3.

ONLINE CONSULTATION.

Author's surname, name [followed by name and surname in the case of additional authors], (year), "article title," URL (date of access in dd/ mm/yyyy format).

Example:

- World Bank (WB) (2002), "Empowerment and poverty reduction: A sourcebook," in http://siteresources.worldbank.org/INTEM-POWERMENT/Resources/486312-1095094954594/draft.PDF (12/11/2009).
- 10. Abbreviations and acronyms: full name must be given upon first mention, followed by parentheses containing the acronym to be employed later.

Examples:

- World Bank (WB), Consejo Nacional de Población (Conapo), gross domestic product (GDP)
- 11. Submissions will be subject to blind peer review. Authors' names or any other form of identification must therefore appear only on the title page. Authors will be informed of our decision within a timeframe of 60 days following reception of the manuscript. Confidentiality will be maintained throughout the process.
- 12. Accepted contributions will undergo copy-editing, and publication will be subject to space availability in each number. Original manuscripts will not be returned.
- 13. *Migration and Development* reserves the right to make whatever editorial changes are deemed relevant.
- 14.
